



# HORSE TRANSPORTATION DOCUMENTS

As of January 1, 2009 the *Livestock Identification and Commerce Act* (LICA) came into effect. This new legislation governs the transportation of horses both within Alberta and to destinations outside Alberta. This communiqué provides an overview of the types of horse transportation documents and when they are used.

## Transportation within Canada

Horses being transported or driven within Alberta are no longer required to be accompanied with a Livestock Manifest unless the horse is being transported for sale or slaughter or to an inspection site (country sale, auction market, livestock assembling station or abattoir).

Horses being transported or driven to another province must be inspected and, depending on the purpose for which they are being transported, can be accompanied with one of the following permits:

Document	Purpose	Cost
Livestock Permit	To transport one or more horses out of Alberta one time only.	\$2.00 per horse
Annual Horse Permit	To transport one or more horse out of Alberta more than once in a calendar year.	\$10.00 per horse
Lifetime Horse Permit	To transport one horse out of Alberta more than once during the lifetime of the horse or the time the person who is issued the permit owns the horse	\$30.00 per horse
Rodeo and Exhibition Permit	To transport a rodeo or exhibition horse out of Alberta more than once in a calendar year	\$10.00 per horse

## Expiry Dates

A Livestock Permit expires on the earliest of the following: 7 days from the date of issue, when the horse is delivered to its destination, or when an inspection is required.

An Annual Horse Permit and a Rodeo and Exhibition Permit expire on December 31 of the year in which the permit was issued or if there is a change of ownership within that same year.

The Lifetime Horse Permit is valid for the life of the horse under the possession of the owner who purchased the permit. This permit is not valid if the horse changes ownership or dies.

## Form of transportation documents

Copies of a Livestock Permit, Special Permit (Annual Horse Permit and Rodeo and Exhibition Permit) and the Livestock Manifest are below.

### **Out of province horses entering Alberta from another jurisdiction**

The sections of the *Livestock Identification and Commerce Act* regarding livestock permits and Livestock Manifests do not apply to persons who transport horses into or through Alberta from an originating point outside of Alberta if:

- the originating jurisdiction requires the horse be accompanied with documentation to be transported out of that jurisdiction to the horse's destination; and
- the horse is accompanied with the documentation.

This exemption (being the ability of the horse to be transported into or through Alberta on it's out of province documentation) expires when the horse:

- stops in Alberta for a purpose other than rest, or
- is required to be inspected in Alberta.

If an out of province horse stops in Alberta for a purpose other than rest, the location where the horse stops is considered to be its originating point for the purpose of having to be accompanied with a livestock permit or a Livestock Manifest to be transported within or outside of Alberta.
